It's been another busy and eventful year for PEPANZ and the wider industry.

Last year was dominated by the Government's shock decision around new exploration permits, but this year has been more about looking ahead.

A number of Government policies will potentially have big impacts on our sector including the Zero Carbon Act, the Minerals and Petroleum Resources Strategy and planned reform to the Crown Minerals Act.

We have seen progress on offshore financial assurance after many years, and income tax exemption for offshore rigs renewed again.

These regulatory issues have kept us busy and reinforced the need for a strong industry body speaking with one voice.

Educating the wider public on our industry has also been a priority. We have featured widely in the media, released a range of new publications and our 'Energy Voices' campaign reaches hundreds of thousands of New Zealanders every week via social media.

2019 has seen a number of corporate changes and transitions with Tamarind purchasing TagOil's New Zealand assets and OMV completing their acquisition of Shell New Zealand. We've also farewelled explorers including Chevron and Equinor from New Zealand. I believe the industry has an exciting future. As we transition to a lower emissions world we will have a major role to play in both the journey and the destination, delivering the energy that creates better lives for billions of people around the world.

This is also my last year as CEO of PEPANZ. It has been a privilege to work on your behalf over the last five years and I remain very proud of what we have achieved.

I want to thank the PEPANZ members, board and staff who have been very supportive of me – especially over the eventful last couple of years.

All the best for a great holiday period and for the exciting challenges ahead.

Our Submissions

PEPANZ has made a wide range of submissions to central and local Government this year on issues affecting our members. We also regularly meet with MPs and officials to discuss these issues in person.

It is pleasing to see progress on offshore financial assurance after many years of discussion with proposals being consulted on that are broadly acceptable. A full list of our submissions is available on the PEPANZ website and includes:

Change in Government Direction for Petroleum and Minerals

PEPANZ has engaged with the Government on two important pieces of work that will set the long-term future direction for the sector.

In November a 'Minerals and Petroleum Resource Strategy' was released by the Ministry of Business, Innovation and Employment (MBIE). This sets out a 10-year vision for "A world-leading environmentally and socially responsible minerals and petroleum sector that delivers affordable and secure resources, for the benefit of current and future New Zealanders."

A discussion document proposing major reforms to the Crown Minerals Act has also recently been released. This is the biggest reform to the legislation in decades and affects nearly every area of how the upstream sector operates.

PEPANZ has been talking to officials and politicians about these important pieces of work to ensure the industry's view is well understood.

Gas Disclosure

PEPANZ, along with gas producers, has been developing a code to ensure disclosure of information about outages at natural gas production facilities.

This industry-led framework is intended to ensure that accurate and timely information about planned and unplanned outages is made publicly available to all interested parties.



Tax Exemption for Offshore Rigs

An important five-year tax exemption for offshore vessels and rigs was renewed by Parliament this year.

PEPANZ advocated for this provision which avoids creating an artificial incentive for vessels to leave New Zealand and be replaced before the threshold of 183 days expires. Government officials agree this is sound tax policy and not a 'subsidy'.

Opposing the 2018 Exploration Decision

The year started with a bang for the Energy Voices campaign as we ran television advertising highlighting the impacts of the 2018 exploration decision.

In February we released a report prepared by NZIER into the economic impacts of the decision which modelled it could cost the economy \$28 billion by 2050. This attracted widespread media coverage and comment.

Engagement on Local RMA Plans

This year we have focussed on strong and well-resourced engagement on local RMA plans in the Taranaki region. It is crucial that we work to preserve sound and workable rules in the Taranaki region, especially given it is the only area in which new permits can be granted under current legislative settings.

For this reason, we have continued the appeal on the South Taranaki District Plan and engaged closely at the hearings on the Taranaki Regional Council's proposed Regional Coastal Plan. We will be involved in the New Plymouth District Plan's hearing following our submission in November.

Thank you to relevant petroleum operators who have supported this important work.

New Publications in 2019

In October PEPANZ published our policy platform "Building a Richer and More Sustainable New Zealand: A Policy Plan for the Upstream Petroleum Sector." This sets out our recommendations for policies to help the sector deliver major economic, environmental and social benefits for New Zealanders.

This year we also published *Powering to 2050: A Vision for Natural Gas in New Zealand* which outlines our vision for the long-term role of our sector.

New Zealand Petroleum Conference 2019

CELEBRATING GREAT ACHIEVEMENTS

The PEPANZ Hall of Fame is a lifetime achievement award presented for outstanding contribution to the oil and gas sector. This year's recipient is Dr Mac Beggs.

Mac began his career with a PhD in Geological Science at the University of California and then worked as an exploration geologist and reservoir specialist with Sohio Petroleum Company in Texas.

In 1988 he returned to New Zealand and has been manager of petroleum geoscience research with GNS Science Science, cofounder and general manager of New Zealand exploration consultancy GeoSphere, and exploration manager for New Zealand Oil & Gas Ltd.

Mac is currently a consultant petroleum geologist and an Adjunct Professor in the Department of Geological Sciences, University of Canterbury. He is also a former Deputy Chair of PEPANZ.

Beach Energy and Todd Energy were also winners at the New Zealand Petroleum Conference Awards this year:

 Excellence in Community Partnership and Engagement: Beach Energy for "It's time to talk Taranaki", a unique community wellbeing collaboration between Beach Energy and local Maori artist Paul Rangiwahia which has reached more than 3000 people. Outstanding Innovation in Oil and Gas: Todd Energy for their initiative to minimise flaring activity which has greatly reduced emissions and impacts on their neighbours.
