ADVOCATE

This year we've had a number of regulatory wins for our members. Highlights include the Government agreeing to work with us on Crown Minerals Act decommissioning reform, the EEZ decommissioning regulations being reworked, and important concessions on marine mammal reserve rules for seismic surveying.





Our submissions

This year we have made 11 submissions to central and local Government on important issues including:

- Crown Minerals Act
- Resource Management Act (RMA)
- Emissions Trading Scheme (ETS)
- EEZ regulations.

We've also worked closely with the Government on important issues like decommissioning policy and ensuring the industry could operate smoothly under Covid-19 restrictions.

Publications

This year PEPANZ produced two key briefing documents to help policy-makers and stakeholders better understand the big issues facing the wider energy sector.

"Asking the burning questions" highlighted our declining natural gas reserves and the challenges this creates both economically and environmentally.

"Energy for better lives" presented the key choices and pathways for the energy sector in the transition to a lower emissions world, and highlighted the principles and policies we recommend.





Gas Information Disclosure Code

A new industry-led disclosure code for natural gas producers came into effect in June. Developed by PEPANZ and gas producers, it provides a public platform with information on unplanned and planned outages at gas production facilities and storage facilities.



In the media

PEPANZ has spoken on behalf of the industry in 137 articles in print, radio, TV and online this year. We have also issued 27 press releases and published four opinion pieces.

Major public issues have included natural gas reserves, the proposed pumped hydro scheme, decommissioning at Tui, anti-industry protest action, and successful projects by OMV.



Social media

This year our educational campaign 'Energy Voices' has reached over 600,000 people with graphics and videos explaining the role of our industry, and especially the importance of natural gas to New Zealand. In total our material has appeared nearly three million times on Facebook and Twitter.



Public opinion

An important benchmark of our influence is the wider public's view of our industry. We were very pleased to see a marked improvement in our annual survey this year with more people having a favourable view (24%) compared to unfavourable (16%). This is a major improvement from two years ago when the respective figures were 19% and 32%.







Collaborating for mutual value

Building relationships with those involved in the wider energy industry has been a priority for PEPANZ this year. We've had hundreds of meetings and engagements and given dozens of speeches and presentations.

- A New Plymouth pre-election event with guest speakers Dr Oliver Hartwich and Phil O'Reilly.
- A political forum in Wellington with spokespeople from all major political parties, including Hon Dr Megan Woods, Jonathan Young and Hon James Shaw.
- Our end of year Christmas party attended by over 100 key industry people.

Next year we will hold even more regular events with industry leaders, politicians, regulators and other relevant guests – so watch this space.

Political engagement

In 2020 we've worked closely with policy makers at both central and local Government level. As well as regular meetings with Ministers and MPs, we also hold regular meetings with officials from the Ministry of Business, Innovation and Employment on regulatory issues important to our members.





SUPPORT

Our team has worked hard this year to deliver excellent support for members and improve how we do things. Some highlights include:

- A new weekly update for members with topical issues we are working on.
- A stakeholder survey to hear the views of key people we work with.

- Updated internal policies.
- Updated websites.
- Moving to a new and more economical office next year.

The option of merging Energy Skills into our organisation from next year is being actively investigated. Attracting, promoting and developing talent for the energy industry is an important challenge and it makes sense to have this under one roof.
